Strong analytical skills for monitoring, assessing and summarizing policies, legislation, and regulations and their impact on energy communities both at EU and national level. Excellent public speaking and communication skills for conveying (often) complex policy information clearly to various stakeholders, including high level policymakers, decision-makers and grassroots initiatives. Sound organizational skills, allowing you to work with others and deliver high quality output in collaboration with people from different backgrounds. You have EU citizenship or have the right to work in the EU.
